Sub: Invitation of applications for the post of Managing Director, Director (Operations) and Head of Projects for OPGC

A. Company & job profile:

Odisha Power Generation Corporation (OPGC), a Government of Odisha Company operates state of the art thermal power plants at Banharpali; Jharsuguda. It has a total generation capacity of 1740 MW (2x210 MW in first phase and 2x660MW in second phase).

1. The Managing Director and Director (Operation) are Board level positions. The Managing Director is the Chief Executive Officer of the company. Director (Operation) is a Board level position. Director (Operation) is responsible for ensuring proper maintenance and operation of the IB Thermal Power Station at Banharpali. Head (Projects) will have overall project management responsibility (AHP modification, MGR railway line, balance of plant work, etc.). The Managing Director is based at Bhubaneswar. Both Director (Operation) and Head (Projects) are based at Banharpali. Both the Director (Operation) and Head (Projects) shall report to the Managing Director. The Managing Director reports to the Chairman, Board of Directors and is accountable to the Government.

After exit of AES, the Government/ OPGC are looking for suitable candidates to be appointed to the aforementioned positions on contract.

B. Selection, Tenure & CTC:

i. Selection will be made based on past experience in operation, maintenance and project. For the position of Managing Director, experience at various levels including regulation and commercial shall be considered. Candidates with experience at the level of Director in Board/ Executive Director/ equivalent position in a reputed power company with atleast 2000 MW installed capacity shall be preferred. For the position of Director (Operation), the candidate should have worked as Head of Plant/ General Manager (Operation/Maintenance)/equivalent of a plant/ station having at least 1000 MW capacity for at least two years. Candidates having experience of super critical power plant shall be preferred. For the position of Head of Projects, the candidate must have worked as project head of a thermal power project involving plants of 500 MW capacity each or higher; for atleast two years. If necessary, these criteria may be relaxed in case of highly deserving candidates.

ii. The candidate must be below 63 years as on 01.01.2021 and be immediately

available to take up the position latest by 15.01.2021.

iii. The Managing Director and Director (Operation) will be taken on contract in MBS E-13 grade of OPGC with CTC in the range of Rs.35 to Rs.70 lac per annum. The contract will be for three years or until the person attains 65 years, whichever is earlier subject to outcome of the annual review of the performance by Government.

iv. The Head of Project shall be taken on either E-13 or E-12 (CTC 34-58 lakhs per year) grade of MBS initially for one year; which shall be extended further based on requirement of the project ,performance and age (upto 65 years).
