In exercise of the power conferred by regulation 2, 5A read with subregulations (2) to (5) of regulation 30 and sub-regulation (1) and (2) of regulation 43 of Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations, 2010 and in partial modification of the notification no-3223 dt. 29th April, 2016 of this Department regarding declaration of notified voltage level for self-certification of electrical installations, it is hereby notified that the voltage level for the purpose of self-certification under regulation 30 and 43 of the said Regulations shall be 11 KV for the power utilities.

The electrical installations of different power utilities namely OPTCL, OHPC, OPGC and the distribution companies (DISCOMs) can be certified by the qualified and experienced electrical engineers of the concerned utility subject to provisions laid down in clause (b) of sub-regulation (1) of regulation 43 of the Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations, 2018 read with section 54 of Electricity Act, 2003.

This notification shall come into force from the date of its publication in the Odisha Gazette.
