**OPERATIONAL GUIDELINES FOR ONE TIME SETTLEMENT OF ARREAR ELECTRICITY
DUTY AND INTEREST IN RESPECT OF CONSUMERS WHO GENERATE ENERGY
FOR THEIR OWN USE OR CONSUMPTION (CAPTIVE CONSUMERS)**

- 1. Short Title:** -Operational guidelines for One Time Settlement of arrear electricity duty and interest in respect of consumers who generate energy for their own use or consumption (Captive Consumers) under Resolution No. ENG-BUD-ED-0005-2019/11797 dated 30.11.2022 of Department of Energy.
- 2. Extent:** -It shall extend to the whole of the State of Odisha.
- 3. Commencement:** -It shall come into force from the date of the issue of these guidelines.
- 4. Definition(s): -**
 - 4.1 EIC (Electricity)-cum-PCEI(O):** Engineer in Chief (Electricity)-cum-Principal Chief Electrical Inspector (Odisha)
 - 4.2 CE-cum-CEI:** Chief Engineer-cum-Chief Electrical Inspector
 - 4.3 ACE-cum-EI:** Additional Chief Engineer-cum-Electrical Inspector
(Superintending Engineer – cum- Electrical Inspector)
 - 4.4 Inspecting Officer:** Chief Engineer-cum-Chief Electrical Inspector or
Additional Chief Engineer-cum-Electrical Inspector
(Superintending Engineer – cum- Electrical Inspector)
- 5. Procedure: -**
 - 5.1** An application made under the resolution, shall be in **Form I** along with relevant enclosures. It shall be submitted in duplicate and accompanied by two copies of the statement of arrear ED as on 31.03.2022. The declaration in

prescribed format appended to these operational guidelines shall also be furnished in form of affidavit before Notary / First Class Magistrate on non-Judicial stamp paper of rupees 100/-.

- 5.2** The said application shall be submitted to the concerned Chief Engineer –cum- Chief Electrical Inspector or Addl. Chief Engineer-cum-Electrical Inspector by the owner or its authorized person within the stipulated period of two months from the date of issue of these operational guidelines.
- 5.3** The concerned Chief Engineer-cum-Chief Electrical Inspector or Addl. Chief Engineer-cum-Electrical Inspector on receipt of the said application shall acknowledge the receipt of the same in **Form II** within 4 (four) days of receipt of application in **Form-I**.
- 5.4** If the concerned Chief Engineer-cum-Chief Electrical Inspector or Addl. Chief Engineer-cum-Electrical Inspector finds any discrepancies or omissions in the application, he/she shall intimate the captive consumer vide **Form II (A)** for necessary compliance for re-submission, indicating details of the same in writing within 8 (eight) days from the date of the receipt of application in **Form-I**. The captive consumers shall comply **Form II (A)** within 12 (twelve) days from the date of receipt of application in **Form-I**.
- 5.5** After compliance by the applicant the acknowledgement of correct application shall be issued by the concerned Chief Engineer-cum-Chief Electrical Inspector or Addl. Chief Engineer-cum-Electrical Inspector in **Form II (B)** within 16 (sixteen) days from the date of receipt of application in **Form-I**.
- 5.6** The concerned Chief Engineer-cum-Chief Electrical Inspector or Addl. Chief Engineer-cum-Electrical Inspector may call for the records pertaining to the assessment and payments made etc. in **Form II(C)** within 25 (twenty-five) days from the date of receipt of application in **Form-I**, as necessary to verify the correctness of the particulars furnished in the said application. The outstanding demand shall be intimated to the Applicant by the Inspecting Officer after obtaining approval from the Settlement Committee constituted under 5.13 to the applicant in **Form II (D)** within 39 (thirty-nine) days from the date of receipt of application in **Form-I**.

- 5.7** The Applicant shall pay 10% of the outstanding demand as per **Form II (D)** and apply in **Form I (A)** to the concerned Inspecting officer within within 49 (forty-nine) days from the date of receipt of application in **Form-I**. For the applications in **Form-II (D)** received beyond this period, the Inspecting officer shall recommend to the Settlement Committee constituted under 5.13 for rejection of the said applications.
- 5.8** The committee constituted under 5.13 shall summarily reject the application, if the applicant has not paid 10% of the Demand issued in **Form II (D)**. The rejection order shall be in **Form III**. Any further application for OTS by the consumer shall not be entertained.
- 5.9** If the consumer deposits 10% of the outstanding demand as per **Form II (D)**, the concerned Chief Engineer-cum-Chief Electrical Inspector or Addl. Chief Engineer-cum- Electrical Inspector shall again verify the correctness of **Form I (A)** with reference to all relevant records & reassess the amount payable as per the resolution No. ENG-BUD-ED-0005-2019/11797 dated 30.11.2022 of Department of Energy and shall putforth before the committee constituted under 5.13 for decisions.
- 5.10** The concerned Chief Engineer-cum-Chief Electrical Inspector or Addl. Chief Engineer-cum- Electrical Inspector shall intimate the settled amount arrived as per the decision of the committee in **Form IV** called settlement order to the consumer with copy to EIC(Electricity)-cum-PCEI, Odisha and concerned Chief Engineer-cum-Chief Electrical Inspector within 56 (fifty-six) days from the date of receipt of application in **Form-I**.
- 5.11** The applicant need to pay the settled amount in full & final as per demand issued in **Form-IV** within a period of two months from the date of issue of this form.
- 5.12** If the consumer finds any difficulty to pay the settled amount within two months of issue of **Form-IV** he may write to the concerned Inspecting Officer along with the reasons, recorded in writing, well in advance at least 15 days before the expiry of stipulated 2 months and the Inspecting officer shall forward the same to EIC (Electricity) for extension of time within 3 days.

- 5.13** The Settlement Committee(s) are to be constituted by the EIC (Electricity) -cum- PCEI, Odisha for finalization of the settlement of arrear Electricity Duty. The concerned Chief Engineer-cum-Chief Electrical Inspector shall be the Chairman, concerned Addl. Chief Engineer-cum- Electrical Inspector shall be the Convener, Technical Assistant to concerned Chief Engineer-cum-Chief Electrical Inspector and Accounts Office/Auditor of the office of the concerned Chief Engineer-cum-Chief Electrical Inspector shall be the member in the said committee. All the relevant records along with application shall be placed before the committee for finalization of the settlement amount.
- 5.14** The settlement committee shall approve the statement of settlement of arrears under the resolution No. ENG-BUD-ED-0005-2019/11797, dated 30.11.2022 of Department of Energy shall be issued in **Form V**. The concerned Chief Engineer -cum- Chief Electrical Inspector or Addl. Chief Engineer -cum- Electrical Inspector shall cause service of the said statement of settlement of arrears with the final settled amount arrived as per the decision of the committee on the applicant endorsing a copy thereof to the EIC (Electricity) -cum- PCEI, Odisha or Chief Engineer-Cum-Chief Electrical Inspector.
- 5.15** The concerned Chief Engineer -cum- Chief Electrical Inspector or Addl. Chief Engineer -cum- Electrical Inspector shall reject the settlement of order in **Form VI** in case of non-payment in full by the applicant after obtaining due approval from the committee.
- 5.16** In case of rejection of settlement of arrears of Electricity Duty and interest, the amount paid by the applicant under this resolution shall be accounted for and adjusted against restored ED arrears as per usual rules/procedures under the relevant Act.
- 5.17** Applications in the prescribed form received after the stipulated period of 2 (two) months from the date of issue of these operational guidelines shall be liable to be summarily rejected.

Revocation of Settlement order:

- 5.18** If it is found that the applicant has obtained the benefit of settlement under this Resolution by suppressing material, information or particulars / furnishing,


incorrect or false information or particulars, the Settlement order shall be liable to be revoked.

5.19 Before revocation of the settlement order of the arrears, the concerned Chief Engineer -cum- Chief Electrical Inspector or Addl. Chief Engineer -cum- Electrical Inspector may issue notice in **Form VII** requiring the applicant to show cause within fourteen days from the date of the receipt of the notice as to why the statement of settlement of arrears issued under the Resolution No.ENG-BUD-ED-0005-2019/11797 dated 30.11.2022 of Department shall not be revoked as per the provision of the Act.

5.20 The concerned Chief Engineer-Cum-Chief Electrical Inspector or Addl. Chief Engineer-cum- Electrical Inspector shall serve the order of revocation on the applicant in **Form VIII**, after obtaining necessary approval of the committee and also endorse a copy thereof to the EIC (Electricity) -cum- PCEI, Odisha and Chief Engineer-Cum-Chief Electrical Inspector.

Mode of Payment:

5.21 The Electricity Duty and interest due under the resolution shall be remitted to Government Treasury through e-payment and as a proof of payment copy of e-challan shall be furnished.


