Subject: "ODISHA TRANSMISSION SYSTEM STRENGTHENING PROGRAMME (OTSSP) PHASE-I UNDER CHIEF MINISTER'S POWER DEVELOPMENT PROGRAMME.

Odisha Power Transmission Corporation Ltd. (OPTCL) being the designated State Transmission Utility (STU) has been developing its transmission infrastructure commensurate with the increase in power demand and requirement of the DISCOMs to facilitate transmission of power from the generating stations to the distribution network. Accordingly, on the basis of system study carried out to identify the necessity of new Grid sub-stations in the State and a thorough deliberation involving all stakeholders, it has been decided to set up 8 nos. of new EHT sub-stations across the State as indicated below under Odisha Transmission System Strengthening Programme (OTSSP) Phase-I.

- 1. 220/33 kV GSS at Nua Betenda (Cuttack)
- 2. 220/33 kV GSS at Sarasmal (Sonepur)
- 3. 220/132/33 kV GSS at Khalikote (Ganjam)
- 4. 220/33 kV GSS at Prajang (Dhenkanal)
- 5. 220/33 kV GSS at Hatabasta (Khurdha)
- 6. 132/33 kV GSS at Bijepur (Bargarh)
- 7. 132/33 kV GSS at Raighar (Nabarangpur)
- 8. 132/33 kV GSS at Jharbandh (Bargarh)

The scheme will be a part of the umbrella scheme Chief Minister's Power Development programme (CMPDP).

The projects will improve the voltage profile at downstream distribution network and thereby improve system stability & reliability. The projects will also provide alternate connectivity to locations which at present are connected to a single source. The projects will further facilitate socio-economic development of the respective areas through reliable power supply to industries, MSME units and LI points.

The projects will be implemented by OPTCL through Engineering, Procurement & Construction (EPC) mode of contract under the direct supervision of Energy Department. The ownership of the assets will lie with OPTCL. The annual operation & maintenance cost will be provided in the Annual Revenue Requirement (ARR) of OPTCL by OERC.

The total cost of the project is Rs. 538.57 Cr. which will be provided entirely from the State Govt. as equity support to OPTCL. The projects will be implemented over a period of 3 years i.e from FY 2023-24 to FY 2025-26.
