1	Clause No. 3(I) under Age Criteria	Minimum age will be 45 (Forty-five) Years and maximum age will be 60 (sixty) years as on the date of advertisement for both internal and external candidates.	Minimum age will be 45 (Forty-five) years and maximum age will be 58 (Fifty-eight) years for internal candidates and 57 (Fifty-seven) years for the external candidates
2	Clause No. 3(III) (A) for Internal Candidates	He/She should have at least 01 (One) year experience in a Senior level position (GM/Sr. GM & above)	He/She should have at least 02 (two) years experience in a senior level position (GM/Sr. GM & above)
3	Clause No. 4 regarding Tenure of appointment	This position is on full time contract basis for a period of 05 (five) years or up to the age of 63 years whichever is earlier	This position is on full time contract basis for a period of 05 (five) years or attaining the age of superannuation i.e. sixty (60) years whichever is earlier. In exceptional cases extension of the tenure may be allowed beyond Sixty (60) years, but not more than 63 years. This will be done only in special case, after due assessment of the performance by PESB.

All other criteria mentioned in the advertisement remain unchanged.
