Teacher in Level- V(A) of the Elementary Cadre.

Such Junior Teachers (Schematic) shall be deemed to have been regularised with effect from the date of their respective joining. These teachers shall be allowed notional service benefits up to 31.12.2025. They shall be entitled to draw regular pay/ salary and other admissible service benefits of Assistant Teachers in Level-V(A) with effect from 01.01.2026.

ORDER: Ordered that this Notification will be published in an extraordinary issue of Odisha Gazette.




